ORDER

In view of the on-going partial lockdown in the state to prevent spread of COVID-19, a District Level Committee is to be set up in each and every district of the state for procurement of available agricultural produce from the farmers and to ensure necessary steps to facilitate marketing of farmer's produce as well as to regulate prices of the agricultural produce during the partial lock down.

The District Level Committee has to be notified by the respective Deputy Commissioners of the district with the following composition.

1	District Development Commissioner of the District	Chairman
2	The CEO, ZP & PD DRDA	Member
3	District Agriculture Officer	Member Secretary
4	All Agriculture Development Officers	Member
5	Inspector of Marketing Board	Member
6	Inspector of Food and Civil Supplies Department	Member
7	All BDOs of the district	Member
8	In charge officer of the KVK of the district	Member

The District Level Committee will assess the farmers produce available in the district and will devise a mechanism for procurement of the produce through existing vendors/suppliers and sale of the same in the district at notified locations and as may be the deputy Commissioners observing all relevant formalities/ guidelines pertaining to COVID-19 and due procedure.

Similarly a State Level Committee has been constituted to supervise and monitor the progress of implementation. The composition of the committee is as follows:

4	The Joint Secretary to the Govt. of Assam, Agriculture Department,	Member

The committees will ensure strict compliances to the directives/ advisories issued by the ASDMA/ Health Department etc. on the COVID-19 during assessment/ procurement/ marketing etc.

This will come into force with immediate effect.


